The City of Concord resolves as follows:

- WHEREAS,** the Concord Police Department has received notification from the New Hampshire Highway Safety Agency that we have been awarded a grant in the amount of up to twenty-one thousand, five hundred seventy-seven dollars and fifty cents (\$21,577.50); and
- WHEREAS,** the Concord City Council approved Resolution #8906, adopted April 11, 2016, at their regular meeting authorizing the City Manager to apply for the above grant; and
- WHEREAS,** these funds have been designated by the New Hampshire Highway Safety Agency to be applied towards DWI/Impaired Driver Patrols and the Concord Police Department desires to conduct such patrols; and
- WHEREAS,** there is an in-kind match by the City in the amount of \$5,394.38 required for accepting these funds; and
- WHEREAS,** this match will be accounted for through administrative costs and equipment costs incurred by the Department through the life of the grant; and
- WHEREAS,** this appropriation is for a purpose not included in the adopted budget, therefore section 37 of the City Charter requires a two-thirds vote of the City Council;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:
