

Dear Mayor Bouley and City Councilors:

We, the undersigned residents of Christian Ave., would like to bring a traffic safety concern on Christian Ave. to your attention and would appreciate your help in evaluating and addressing this issue.

Good visibility with ample field of vision is essential for safe road travel. There are specific site level issues on Christian Ave. that impede lateral visibility and field of vision for drivers exiting parking lots/ driveways. Christian Ave. has eight driveway/parking lots on the north side of the street.

The lateral visibility and field of vision is very poor upon pulling out of these parking lots onto Christian Ave. due to legally parked vehicles. Drivers are required to slowly inch out a significant way into the travel lane before being able to see if traffic is approaching from either direction. The situation is compounded by speeding vehicles and illegally parked vehicles, but exists even without these factors.

We would appreciate having this situation addressed proactively to improve safety by improving visibility. One possible solution is the installation of wide-angle convex road safety mirrors, but there may be other potential solutions.

We would appreciate your following established procedures to:

1. Conduct a road safety audit to assess roadway elements, vehicle factors and human factors that contribute to the safety issue. Elements of specific concern include the variety of user capabilities and limitations evidenced by young drivers and older drivers who travel this road.
2. Identify specific solutions that improve lateral visibility and field of vision, including but not limited to installing convex mirrors.
3. Meet with stakeholders and discuss the pros and cons of potential solutions/ strategies.
4. Select and implement strategy or strategies that improve visibility upon exiting parking lots/driveways and therefore improve safety.
