My name is Kay Braeburn and I live at 34 High Street in Penacook. I am writing in support of reducing the property line buffer to keep pet chickens from the current 30 feet to the proposed 5 feet when the Counsel votes on October 15th.

I own a home in Penacook and while I grew up keeping chickens (including one who lived to be 10 years old) there isn't quite enough space on our 1/3 acre lot at the current 30-foot buffer rules to keep a small coop of laying hens.

Chickens aren't only great for fresh eggs and their cute personalities:

- They're amazing at reducing the number of pests like ticks, mosquitoes, slugs, and small mice.
- They reduce household waste by eating table scraps and lawn clippings.


Good Morning, Janice!





