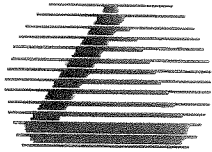

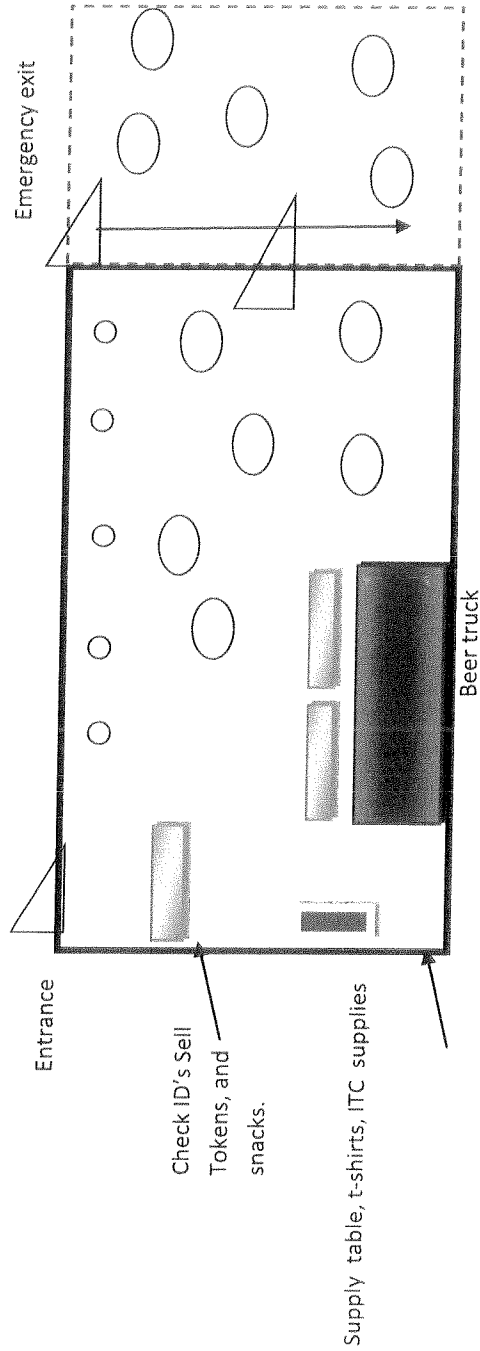

Procedures: The Beer/Wine Hospitality Tent is operated by Intown Concord, Susan Sokul is the Person in Charge. MTS training completed. All volunteer servers will be required to take TEAM training. There are primarily BOD members who work the beer tents. Volunteers will be selling beer/wine tokens. Volunteers will take the TEAM for the ID process and serving beer/wine.. Service closes at 10pm. Festival closes at 10pm. To be served a beer/wine ID 'safe checked and the person receives a wristband. We are estimating seating and service for a maximum of 60 people. We have about 900 sq ft under the tent. (18at high tops, 40 sitting down) Outside beer garden is can accommodate 30 more guests.

Our entrance and exits will be staffed to insure beer/wine is not removed from the tent or garden area. Chips and cracker, water, soda will be available in the tent for sale. No smoking allowed.

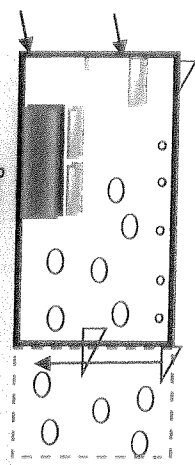
