The City of Concord resolves as follows:

- WHEREAS, on May 17, 2021 the City entered into a Purchase and Sale Agreement with the John J. Flatley Company (the Developer) concerning the sale and redevelopment of real estate known as the former New Hampshire Employment Security Property (the "Property") located at #32-34 South Main Street and 33 South State Street (CIP #578); and
- WHEREAS, subsequent to the Parties executing the Purchase and Sale Agreement, additional Asbestos Containing Materials (ACM) were discovered that had not been identified in a 2014 Hazardous Building Materials of the Property commissioned by the City; and
- WHEREAS, in accordance with an amendment to the Purchase and Sale Agreement, the Developer has agreed to be responsible for ACM located on the exterior of the former office building at the Property in exchange for a \$150,000 payment from the City at the time of closing; and
- **WHEREAS**, the City is pursuing a financial settlement with consultant that prepared the 2014 Hazardous Building Materials Survey; and
- **WHEREAS**, the City desires to appropriate the sum of \$150,000 from the Economic Development Reserve for this purpose; and
- WHEREAS, any proceeds from the anticipated funds from the consultant who prepared the 2014 Hazardous Building shall be used to reimburse the Economic Development Reserve for this appropriation; and
- WHEREAS, this appropriation is for a purpose for which funds are not included in the Fiscal Year 2022 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.
