Regional Drive Expansion Project in the amount of \$66,101.05; and

WHEREAS, the Recreation District 1 & 3 items will be used to offset debt service costs for the

City-Wide Community Center Project in the amount of \$46.33; and

WHEREAS, a reduction in the amount to use from fund balance in the General Fund will be

allocated as the offsetting reduction in revenue projection; and

WHEREAS, this appropriation is for a purpose not included in the Fiscal Year 2022 adopted

budget, therefore section 37 of the City Charter requires a two-thirds vote of the

City Council.
