The City of Concord resolves as follows:

- WHEREAS,** in 1999, City Council approved Resolution No. 6922 establishing a trust fund for the planting of street trees along the right of way in urban areas of the City utilizing donations; and
- WHEREAS,** additional funds have been deposited into the Trust Fund through private donations and in lieu payments through the Planning Board for the cost of the required trees not installed; and
- WHEREAS,** the appropriation of the funds from the Trust Fund shall be by the City Council; and
- WHEREAS,** the Street Tree Policy established in 2015 sets policy to promote planting, preserving, and the proper care and maintenance of street trees and plantings within the City limits, enhancing the attractiveness and environmental health of the City, thereby promoting the general and economic well-being of the City; and
- WHEREAS,** in 2021, with City Council approval, the Tree Subcommittee initiated a cost sharing element to the Sustainable Tree Program in order to expand access to the program for more residents in order to improve the urban canopy in the City rights of way; and
- WHEREAS,** at the request of the Tree Subcommittee, the Concord Conservation Commission recommends the appropriation of \$5,000 from the Urban Tree Trust Fund into a project fund to continue supporting the cost-sharing program; and
- WHEREAS,** these funds may be utilized to assist with the cost of planting trees within the City right of way under the Sustainable Tree Program for plant materials, soil enhancements, structural soils, and other best management practices to ensure the survivability of the trees; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:
