#### The City of Concord resolves as follows:

the City Council authorized \$900,000 for the Beaver Meadow Parking Lot WHEREAS. Project (CIP #107); and

WHEREAS. the scope of the project has changed to include the addition of a retention pond for drainage as required by the Alteration of Terrain permit issued by New Hampshire Department of Environmental Services; and

the cost of the project has increased due to inflationary pressures as the result WHEREAS, of delayed pricing; and

WHEREAS, the project also anticipates including electrical and water lines to the driving range area for future snowmaking, in partnership with SkitheBeav, an additional \$43,000 cost to be funded in the form of donations; and

WHEREAS, it is projected that the additional \$107,000 capital expense will be borne by the Golf Fund as bonded debt service; and

this appropriation is for a purpose for which funding was not included in the WHEREAS, Fiscal Year 2025 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.
