The City of Concord resolves as follows:

WHEREAS,	Loudon Road (NH 9) Bridge over the Merrimack River ((#163/111), also known as the World War II Veterans Memorial Bridge, is a municipally-owned bridge that has been "red listed" by NHDOT; and
WHEREAS,	NHDOT inspects red listed bridges annually; and
WHEREAS,	the City has received a Critical Bridge Deficiency letter from NHDOT due to the fact that the most recent inspection resulted in the deck condition evaluation being downgraded from Poor Condition to Serious Condition; and
WHEREAS,	the City has estimated the cost of bridge deck evaluation, design, and repair to be \$200,000; and
WHEREAS,	NHDOT has indicated that the proposed interim repairs are not eligible to be included for funding assistance in the Loudon Road Bridge Rehabilitation Project that has been included in the State's Ten-Year Plan; and
WHEREAS,	the City has established a Bridge Reserve Fund, which allows City Council to appropriate funds as needed for their intended purposes including the maintenance, construction, or reconstruction of municipally-owned bridges; and
WHEREAS,	the requested sum of \$200,000 is available in the Bridge Reserve Fund; and
WHEREAS,	this appropriation is for a purpose for which funding was not included in the Fiscal Year 2025 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:
