Good Afternoon Chief Chisholm,

My name is Billy Tufts. I am a the Supervisory Deputy United States Marshal here in Concord NH. I run the NH Joint Fugitive Task Force comprising members of the Marshals Service, Strafford County Sheriffs Office, Rockingham County Sheriff's Office, Hillsborough County Sheriff's Office, Merrimack County Sheriffs office and the Greenfield Police Dept. Our mission is to locate and apprehend violent fugitives within the state and around the country. We spend a lot of time breaching doors and making entry into hard to access residences with various types of doors.

Today we had the pleasure of having a period of instruction by FF Brad Newbury at your departments training facility on Old Turnpike Rd. Brad provided intimate knowledge of all things doors and how a fire fighter approaches gaining entry. This provided our team valuable insight on many doors we tend to face in the course of our duties. Brad took the time to refamiliarize us on the incredible benefits of the Halligan and ways we can implement it into our tactics. Although our tactics differ slightly at a door, Brad called upon his time in the Marine Crops and was able to provide a thoughtful and logical approach on how we may best implement the Halligan in our operations.

Typically we use our ram and smash the door down. We almost always have a Halligan with us yet rarely deploy it due to our lack of understanding of the effectiveness. Moving forward, our team has built a solid foundation on how we can breach various doors.

Brads style of training and instruction makes it clear he has a passion for the tradecraft but also wants to help others make themselves better and add new tools to our tool box.

My team and I would like to pass on our appreciation to the CFD and Brad for allowing us to come train and sharpen a skillset that needed sharpening.
