The City of Concord resolves as follows:

WHEREAS, the Fiscal Year 2021 capital improvement plan approved \$60,000.00 for the Fire Station Location Study project and, in Fiscal Year 2023, \$70,000 for the Station 1 Apparatus Bay Reconstruction project; and

WHEREAS, the Station Location Study was successfully completed and presented to City Council on February 14, 2022; and

WHEREAS, at least one apparatus bay at Station 1 will require reconstruction in order to physically fit the height of the new Tower truck ordered with funds from the FY23 Fire Department Apparatus CIP (CIP #4); and

WHEREAS, a quote valid until July 1, 2023 has been obtained for simultaneously reconstructing two (2) apparatus bays at Station 1 for \$99,808.07; and

WHEREAS, reconstructing two (2) apparatus bays instead of one (1) would be a significant benefit to the Fire Department; and

WHEREAS, repurposing the remaining \$30,025.00 from the Station Location Study subproject to augment the existing Station 1 Apparatus Bay project will allow for the reconstruction of two (2) apparatus bays; and

WHEREAS, the savings from the completed Station Location Study project is largely due to the availability of information from the H.L. Turner Group Inc. city-wide Facility Conditions Assessment; and

WHEREAS, this repurposing of bond proceeds requires a two-thirds vote of the City Council under RSA 33:3-a, II.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:

1) The sum of\$30,025.00
be and is hereby repurposed as follows:

General Capital Project Fund
Fire Facility Renovation (CIP #252) – Bay Reconstruction\$30,025.00
