The City of Concord resolves as follows:

- **WHEREAS**, as part of CIP #78, the City, as the owner of the parcel known as Map 0543P, Lot 18, will dedicate land along the frontage of its parcel to widen a portion of the public highway known as Canal Street; and
- WHEREAS, as part of CIP #78, Caleb Penacook Limited Partnership, as the owner of a parcel to the east of the parcel owned by the City and known as Map 0543P, Lot 18-1, will dedicate land along the frontage of its parcel and convey a public highway right-of-way easement deed to the City to widen a portion of the public highway known as Canal Street; and
- WHEREAS, as part of CIP #78, Caleb Penacook Phase 2 Limited Partnership, as the owner of a parcel to the east of the parcel owned by the City and known as Map 0543P, Lot 18-2, will dedicate land along the frontage of its parcel and convey a public highway right-of-way easement deed to the City to widen a portion of the public highway known as Canal Street; and
- **WHEREAS**, as part of CIP # 567, the City will discontinue completely a portion of the public highway known as Canal Street; and
- **WHEREAS**, the City is the underlying fee owner of the portion of the public highway known as Canal Street to be discontinued continued, and will voluntarily merge the land into the City's parcel known as Map 0543P, Lot 18; and
- WHEREAS, the City Council may accept 1) the dedicated land along the City's parcel known as Map 0543P, Lot 18; 2) the dedicated land along Caleb Penacook Limited Partnership's parcel known as Map 0543P, Lot 18-1; and 3) the dedicated land along Caleb Penacook Phase 2 Limited Partnership's parcel known as Map 0543P, Lot 18-2, all as part of the public highway known as Canal Street; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord:

1) That the City accepts the three dedicated parcels adjacent to 1) the City's parcel known as Map 0543P, Lot 18; 2) Caleb Penacook Limited Partnership's parcel known as Map 0543P, Lot 18-1; and 3) Caleb Penacook Phase 2 Limited Partnership's parcel known as Map 0543P, Lot 18-2, as part of the public highway known as Canal Street.
