The City of Concord resolves as follows:

- **WHEREAS**, the City of Concord approved the Fiscal Year 2025-2034 Capital Improvement Project (CIP), which included the Conceptual Study in CIP #323; however, the subproject was asterisked, funding was not appropriated; and
- **WHEREAS,** the area at the COMF currently leased by the Concord School District (CSD) was designed to house various industrial-scale workshops. Ad hoc measures were made over time to accommodate the operational and administrative needs of the CSD Transportation Department; and
- **WHEREAS**, the CSD is interested in a long-term partnership with the City, as evidenced by their participation in the financing of the recent fuel station upgrade. The Department and CSD feel it is in their mutual best interests to develop a long-range conceptual plan for the shared area of the COMF; and
- **WHEREAS,** the conceptual plan would address space allocation, equipment needs, building utilities, security, adequate separation of City and CSD operations, and parking, anticipating a 20-year occupancy
- **WHEREAS,** monies in the sum of \$35,000 received from CSD for this program will offset the cost of the conceptual study; and
- **WHEREAS,** this appropriation is for a purpose not included in the Fiscal Year 2025 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.
