**The City of Concord resolves as follows:**

**WHEREAS,** the City of Concord was eligible to apply and receive funding for updating the SWPPP; and

**WHEREAS,** Resolution #9369 approved at the April 12, 2021 City Council meeting authorized the City Manager to apply for a grant in the amount up to \$8,425; and

**WHEREAS,** Resolution # 9461 approved at the May 9, 2022 City Council meeting and authorized \$8,500 for this purpose and project funding was to be allocated as follows: \$7,650 (90%) Federal share, \$425 (5%) State share, and \$425 (5%) City share; and

**WHEREAS,** Federal Aviation Administration (FAA) informed the City of Concord in late fall 2022 that their Airport Improvement Grant Program would no longer fund updates to Airports SWPPP; and

**WHEREAS,** as a result the FAA's appropriation of their 90% project match in the amount of \$7,650 and the State and City's appropriation of their 5% project match in the amount of \$425 each may be deauthorized and rescinded; and

**WHEREAS,** Funds in the amount of \$8,500 have been programmed in the FY25 Annual Airport Operating Budget for the update of the SWPPP; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Concord that:
