The City of Concord resolves as follows:

WHEREAS, the onsite septic system located at 69 Shawmut Street has failed; and,

WHEREAS, in accordance with Article 9-6-5 of the City Code of Ordinances, #69
Shawmut Street is located within 200' of municipal sanitary sewer mains

and therefore must be connected to the municipal sewer system; and,

WHEREAS, the owner of #69 Shawmut Street, together with their neighbors located at

#61 and #65 Cemetery Street, have design a new 215' +/- sewer main extension as shown on plans titled "Utility Improvement Project" prepared by Rokeh Consulting, LLC" dated July 10, 2025 which will provide municipal sanitary sewer service to all three properties by extending a

sewer main located in Cemetery Street; and,

WHEREAS, the sewer main and related improvements shall be constructed at sole the

expense of the property owners in accordance with plans and specifications

approved by the Engineering Services Division of the Community

Development Department; and,

WHEREAS, acceptance of the proposed sewer main extension into the municipal sewer

system will require the property owners to complete sewer improvements in accordance with approved plans and specifications, as well as to provide the City with required sanitary sewer easement rights associated therewith;

and,

WHEREAS, in addition to conveying required sewer easements to the City, the owners

of the aforementioned properties desire to also provide the City with rights to construct future sidewalk extensions from #59 Cemetery Street to

Shawmut Street; and,

WHEREAS, extension of the municipal sanitary sewer and sidewalk system on

Cemetery Street is desirable and furthers public health, safety, and welfare.
