AN ORDINANCE amending the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking, Article 18-1, Stopping, Standing and Parking

The City of Concord ordains as follows:

SECTION I: Amend the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking, Article 18-1, Stopping, Standing and Parking, Section 18-1-6 (a), Parking Prohibited at All Times in Designated Places, by amending Schedule I, as follows:

SCHEDULE I

Parking Prohibited at All Times (See Section 18-1-6(a)):

SECTION II: Amend the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking, Article 18-1, Stopping, Standing and Parking, Section 18-1-8, Parking Time Limited in Designated Places, by amending Schedule III, as follows:

Two Hours (between the hours of 7:00 a.m. and 6:00 p.m. Monday through Friday)

SECTION III: Amend the CODE OF ORDINANCES, Title II, Traffic Code; Chapter 18, Parking; Article 18-1, Stopping, Standing and Parking, Section 18-1-9, Bus and Taxicab Stands, by amending Schedule VII, as follows:

Bus and Taxicab Stands (see Section 18-1-9)
