During the Woodcrest Heights Association Annual Meeting this past month, members unanimously voiced concern about how our streets continuously just get patched which last about a week or so then rocks go flying all over the place which could hit a car or kids. Our neighborhood is made up of 90 homes who pay taxes, and most homes have been built since 1979. At that time there were probably 1 or 2 cars per home and much less traffic. Now our neighborhood has additional traffic that was allowed to enter and leave such as residents of Center Stone-Salisbury Green, and the numerous trucks in and out of our road such as Amazon, Federal Express, UPS, caused by our new way of life that also destroys our roads. I think that asking our city for a complete resurfacing (reclaim) of our streets, which consist of Woodcrest Heights Drive, Chesterfield Drive, Pine Acres Road and Wedgewood, has been long overdue. Residents were once told years ago that our neighborhood roads were part of the city's 10-year plan which has now been decades ago.

Additionally, as a separate issue of concern which will need to be addressed, we also now must contend with trying to get in and out of our neighborhood due to the car wash (Washville) and DQ whose entrances are directly across our entrance and have already had a few accidents. I graciously invite any council member to come to our neighborhood and experience coming in and out of our entrance.
