SUBJECT: December Fiscal Year-to-Date 2025 Financial Statements

The attached financial statements for the period ending December 31, 2024 represent 50% of the elapsed Fiscal Year 2025. The highlights of the City's financial status for this time period are presented by fund or groups of funds below. Comparisons are being made to the FY25 adopted budget and previous year FY24 same period results.

General Fund

Revenues:

- 1) 50% of the way through the Fiscal Year, revenue and expense lines are on track. Current trends are identified below and new trends that develop will be identified as early as possible.
- 2) Finance –
 - a. Motor Vehicle Registrations are \$224,100 ahead of FY24 and on target with budget at 49% YTD.
 - b. Investment income is \$15,100 behind FY24 and ahead of budget at 55%. With the recent interest rate cuts by the federal reserve, this revenue line is softening and I expect to collect less than FY24 and on par with FY25 budget.
- 3) Fire –
 - a. Ambulance Charges are ahead of budget at 53% and ahead of FY24 by \$83,400.

Expenses:

- 1) Most expense items are on track with budget. December represents 25 of 52 payrolls elapsed or 48.08%. This is the ratio that is important to use to compare wage lines to budget. It is important to note that FY25 represents 3 payrolls for July as compared to 4 payrolls for July in FY24. Other notable items are listed below.

2) Police –

- a. In December 2024, the Police Department hired a new police officer who is preparing to go to the NH Police Academy in January 2025. As of December 31, 2024, there are twelve police vacancies (ten police officer positions, one Sergeant position, and one Lieutenant position). One officer is on other leave status, and two officers have significant long-term injuries. One of the two injured officers is back to work and is working temporary alternate duty in non-enforcement responsibilities. The second officer has undergone a complex surgery and is anticipated to have a significant recovery period. This officer's injury was sustained on duty during a struggle with a person being arrested. Their absence from the patrol division adds tremendous voids to a stressed work unit. The Department is still in a staffing crisis and struggling to backfill key positions within patrol and supervisory levels. Significant overtime is being spent to cover basic police services throughout the City. Recruitment remains challenging and is at an all-time low. Watch Commanders have resorted to staffing patrol shifts at the bare minimum. We anticipate at least two additional retirements shortly in the sworn ranks of the Department.
- b. Another area of concern is our dispatch center. There are two vacancies out of seven positions in dispatch. Dispatch is actively recruiting candidates and the applicant pool is slightly better for civilian jobs than for the sworn positions. Vacant dispatch shifts are being covered with temporary employees and police officers on overtime. This has significantly increased overtime spending in dispatch.
- c. Overall wages and benefits are 48% spent and \$337,700 more than FY24. Overtime is 100% spent and \$188,600 less than FY24. Included in the overall wage and benefit expenses is the annual charge, \$99,800 for workers compensation. These accounts will be closely monitored through the remainder of the fiscal year.

3) Fire –

- a. As of December 31, 2024, the Fire Department has three Firefighter/Paramedic vacancies, one Firefighter/Paramedic on TAD, one Firefighter/AEMT vacancy, one Firefighter/AEMT vacancy as a result of temporary reassignment to the Fire Prevention Division and one Fire Alarm Operator Vacancy.

Despite ongoing efforts, the Fire Department continues to face a recruitment and retention crisis. This has resulted in increased overtime being spent to staff unfilled positions.
- b. Overall wages and benefits are 52% spent and \$280,800 more than FY24. Overtime is 80% spent and \$229,700 more than FY24. Included in the overall wage and benefit expenses is the annual charge, \$516,200 for workers compensation. These accounts will be closely monitored through the remainder of the fiscal year.

4) General Services –

- a. Snow and Ice Removal – there were ten treatable events through December 31, 2024, eight of which required overtime. Overtime is 36% spent or \$71,800 more

than FY24. Winter treatment supplies are 83% spent including encumbrances and \$194,600 less than FY24.

5) Human Services –

- a. Special Program expenses are up \$17,600 more than last year or 56% of budget due to the cost of hotels and difficulty finding space for other unhoused individuals and families.

Major Enterprise and Special Revenue Funds:

Parking Fund

No significant issues to discuss at this time.

Airport Fund

No significant issues to discuss at this time.

Golf Course Fund

Overall revenues are \$59,800 more than FY24 and 59% of budget. Expenses are \$29,200 less than FY24 and 53% of budget. Overall net is \$221,900 compared to \$132,900 or \$89,000 more than FY24.

Arena Fund

Overall revenues are \$27,400 less than FY24 and 48% of budget. Expenses are \$6,900 more than FY24 and 49% of budget. Overall net is (\$8,900) compared to \$25,400 or \$34,300 less than FY23.

Solid Waste Fund

No significant issues to discuss at this time.

Water Fund

No significant issues to discuss at this time.

Sewer Fund

No significant issues to discuss at this time.

All departments do a great job of monitoring their individual divisions and departments. These statements, which as provided in this format on a monthly basis, will help articulate how the City is doing overall as the fiscal year progresses.
