The City of Concord resolves as follows:

WHEREAS, City Staff was approached by the developer of the Next Step Living project

located at 3 North State Street, which proposes to convert the former commercial building into housing for individuals with developmental

disabilities; and,

WHEREAS, the developer of the Next Step Living project seeks assistance in obtaining

soon to be expiring Invest NH grant funding for the internal demolition related to converting the commercial space into housing (\$35,000) and for

the creation of the affordable housing units (\$30,000); and,

WHEREAS, only municipalities are permitted under state law to apply for Invest NH

grant funding; and,

WHEREAS, the City of Concord is eligible to apply for the Municipal Per Unit Grant

Program (MPUGP) and the Municipal Demolition Program (MDP) for funds given as an incentive to support the permitting and approval of

affordable housing units at the local level; and,

WHEREAS, grant funds are available through the Invest NH initiative, which includes

both the MPUGP & MDP; and,

WHEREAS, the City can apply for up to \$10,000 per eligible affordable housing unit for

the MPUGP; and,

WHEREAS, the City was previously granted a maximum award cap waiver from the

State of NH, allowing the City the ability to receive a maximum award of up to \$2,000,000 for the MPUGP (for projects utilizing universal design elements) and the City has to date been awarded a total of \$1,140,000 in MPUGP funding (leaving the City eligible for up to \$860,000 of additional

funding); and,
