The City of Concord resolves as follows:

WHEREAS, the City of Concord was awarded Land and Water Conservation Fund (LWCF) grant funding in the amount of \$100,000 to construct part of the Merrimack River Greenway Trail elevated boardwalk (CIP #543); and

WHEREAS, the boardwalk project did not move forward as the cost of the project came in over budget; and

WHEREAS, the City Council and the LWCF approved the use of the previously awarded funds to help construct Phase 1 of Terrill Park (CIP #59); and

WHEREAS, as a result in the agreed upon change in the use of those funds, the Parks and Recreation Department and Engineering Division request to rescind the appropriation of the LWCF grant funds for use on the Merrimack River Greenway Trail 2016 Trail & Boardwalk Construction subproject (CIP #543); and

WHEREAS, as a result in the agreed upon change in the use of those funds, the Parks and Recreation Department and Engineering Division request to affirm the acceptance of the LWCF grant funds for use on the Terrill Park 2020 Greenway Trail Improvements subproject (CIP #59).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:
