

CITY OF CONCORD

AN ORDINANCE amending the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking, Article 18-1, Stopping, Standing and Parking

The City of Concord ordains as follows:

SECTION I: Amend the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking, Article 18-1, Stopping, Standing and Parking, Section 18-1-6 (a), Parking Prohibited at All Times in Designated Places, by amending Schedule I, as follows:

SCHEDULE I

Parking Prohibited at All Times (See Section 18-1-6(a)):

Street	Side Restricted	From	To
{South Main St.}	{East}	{190' north of South State St.}	{Pillsbury St.}
<i>South Main St.</i>	<i>East</i>	<i>20' north of crosswalk at Allison St.</i>	<i>21' south of Allison St.</i>
<i>South Main St.</i>	<i>East</i>	<i>Water St.</i>	<i>200' north of Gas St.</i>
<i>South Main St.</i>	<i>West</i>	<i>250' north of South State St.</i>	<i>Maitland St.</i>

SECTION II: Amend the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking, Article 18-1, Stopping, Standing and Parking, Section 18-1-8, Parking Time Limited in Designated Places, by amending Schedule III, as follows:

SCHEDULE III

Parking Time is Limited in Designated Places (see Section 18-1-8):

One Hour (between the hours of 7:00 a.m. and 6:00 p.m. Monday through Friday)

Street	Side Restricted	From	To	Position to Curb
{South Main St.}	{East}	{150' north of South State St.}	{Gas St.}	{Parallel}
{South Main St.}	{West}	{215' south of Pillsbury St.}	{Maitland St.}	{Parallel}

Two Hours (between the hours of 7:00 a.m. and 6:00 p.m. Monday through Friday)

Street	Side Restricted	From	To	Position to Curb
{South Main St.}	{East}	{150' north of South State St.}	{Gas St.}	{Parallel}
<i>South Main St.</i>	<i>East</i>	<i>Gas St.</i>	<i>20' north of crosswalk at Allison Street</i>	<i>Parallel</i>
South Main St.	West	<i>60' south of West St.</i>	{150' north of South State Street} <i>188' south of West Street</i>	Parallel

Ten Hours (between the hours of 7:00 a.m. and 6:00 p.m., Monday through Friday)

Street	Side Restricted	From	To	Position to Curb
<i>South Main St.</i>	<i>East</i>	<i>21' south of Allison St.</i>	<i>150' south of Pillsbury St.</i>	<i>Parallel</i>
<i>South Main St.</i>	<i>East</i>	<i>200' north of Gas St.</i>	<i>Gas Street</i>	<i>Parallel</i>
<i>South Main St.</i>	<i>West</i>	<i>188' south of West St.</i>	<i>250' north of South State St.</i>	<i>Parallel</i>

SECTION III: This ordinance shall take effect upon installation of signage and pavement markings.
