RE: Proposed Acquisition of Real Estate from Pan Am Systems

Dear Mayor Bouley and City Councilors:

The Conservation Commission submits this letter in support of the proposed acquisition of approximately 76 acres, consisting of two segments of railroad corridor land from Pan Am Systems, Inc. to support the Merrimack River Greenway Trail (MRGT) and the Concord-Lake Sunapee Rail-Trail.

The acquisition of these railroad corridors within the City presents a unique but fleeting opportunity. Absent the acquisition of the entire corridor, these old railroad corridors are typically sold off in segments to adjacent landowners and the open corridor is lost forever. The acquisition of these corridors meets several long-standing goals of the Conservation Commission. The corridor lands are located along the Merrimack River and within the river's floodplain, which has long been a focus area for conservation efforts. The acquisition of these corridors also meets the established goal of connecting conservation and open space lands throughout the City, and connecting neighborhoods to such lands, which are managed for multiple use. Finally, the development of trails on these corridor segments provides an opportunity for Concord to connect to two regional trail systems. The extension of the Merrimack River Greenway Trail (MRGT) along the 72.53-acre corridor extending to the Boscawen line provides Concord with the opportunity to connect to the regional trail extending to West Lebanon. The shorter 5.5-acre segment, if developed with a trail, could eventually connect with the regional Concord-Lake Sunapee Rail Trail. The development of such trails within Concord and the connection to these regional trails would be a tremendous recreation and transportation asset to Concord.

The current proposed appropriation for these acquisitions is \$700,000, consisting of \$600,000 in General Fund supported bonds and notes that the City Administration recommends be credited against the bond established for the Acquisition of

Conservation Land and Open Space. The Conservation Commission has used this bond, with City Council's approval, for conservation projects of significant importance to the City that would not be possible without the bond. The acquisition of the corridor from downtown Concord to the Boscowen line is such a project and we support the use of the bond for this acquisition.

The City Administration proposes that the \$100,000 balance of the acquisition budget be funded from the Conservation Reserve Fund. That amount consists of \$71,350 for the purchase price for the 5.5-acre corridor segment extending from the Pierce Manse to Brook Street along the former Concord-Claremont Line, plus \$28,050 for environmental assessments, title and closing costs.

In terms of the funding for this smaller parcel, the Conservation Commission requests that the City Council consider reducing the amount to be funded from the Conservation Reserve Fund to just the negotiated purchase price of \$71,350, and increase the amount to be credited against the bond to \$628,050. We make this request for three reasons.

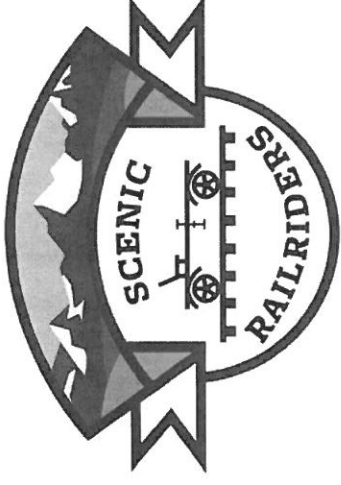
First, at the time City Administration first met with the Commission about funding, the balance of the Conservation Reserve Fund was higher than it is today. The proposed acquisition cost is also higher than we expected when the \$28,050 estimated for environmental assessments and closing-related costs is added to the purchase price. Second, the current balance of the Conservation Reserve Fund is \$579,437, but the Commission has earmarked \$225,000 of that amount for another possible acquisition that remains in the early stages. After accounting for both projects, the Conservation Reserve Fund will be significantly depleted, which limits the Commission's ability to pursue other conservation opportunities that are beneficial to the City. Third, the Conservation Reserve Fund is funded by money collected by the City from the Land Use Change Tax (LUCT). Although the Conservation Reserve Fund used to receive 100% of the LUCT revenue, the allocation was cut to 50% in 2007 and remains at that level. In addition, there is a finite amount of land within the City limits that is subject to the LUCT when it is developed, so the replenishment of the Conservation Reserve Fund is anticipated to decrease over time.

The proposed acquisition of these corridor lands presents an outstanding conservation, recreation, transportation and economic opportunity for the City. The Conservation Commission fully supports the proposed acquisition.

# Why have a Trail & Rail-Bikes?

- Scenic RailRiders has brought a much needed tourist attraction to the Concord NH area and to take that away would greatly hurt the NH economy of many local businesses as well as take state and city revenue.
- Allowing Scenic RailRiders to continue to operate on the abandoned tracks in Concord and Boscawen brings great economic benefit to New Hampshire and many local businesses in Concord and surrounding areas. As the owner of Scenic RailRiders, I see no reason why both Scenic RailRiders and a rail trail cannot co-exist to benefit the State of New Hampshire along with Concord and the surrounding Cities and Towns.
- Included in a City of Laconia Proposed Rail-Trail Franklin to Weirs Beach Economic Study Report dated October 2019, NHDOT's director of the Division of Aeronautics, Rail and Transit, Patrick C. Herlihy, wrote, "...existing and future rail service must take priority over recreational trail use in any [S]tate-owned rail corridor," and that expansion of the proposed trail network "...cannot be at the expense of the existing passenger excursion rail service that has supported tourism in the Lakes Region, including the City of Laconia, for over 25 years."
- Even though Scenic RailRiders is not operating scenic locomotive rides, we are operating scenic rides on the railroad tracks, similar to a scenic locomotive ride. In fact, our scenic rides can be considered more scenic as our riders have an unobstructed 360 degree view as they pedal along the tracks.
- Just like other Railroad companies, Scenic RailRiders is registered with the Federal Railroad Administration and required to file monthly usage reports for operating Rail Bike Tours on the abandoned remaining section of the Northern Railroad.



# Tourism & Economy

- Tourism is one of the largest driving factors for the New Hampshire economy and tourist rail services is an important part of that economy. According to the 2012 NH State Rail Plan, it's recommendation is to: "Support Tourist/Excursion Rail Services. Continued support by the state through railroad maintenance activities will help to maintain these important services and perhaps even expand or initiate new tourist railroad services." So clearly, removing rails which are still in use goes against the 2012 NH State Rail Plan recommendation.
- Scenic RailRiders expects to have approximately 20,000 riders for the 2021 season running from mid May to end of October. We also expect that 54% of our riders will come from outside of NH and 94% come from outside the Concord area. No walking/bike path will bring as many people to Concord!
- Three TV shows have come to Concord to do stories on us, NH Chronicle, New England Living, NH Life. All of these have helped bring people to the Concord Area.

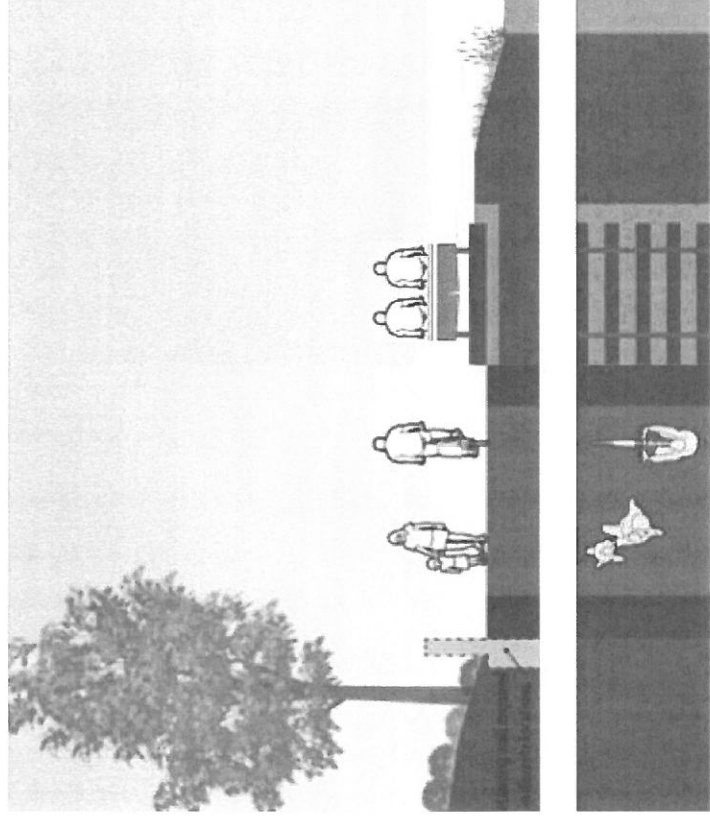
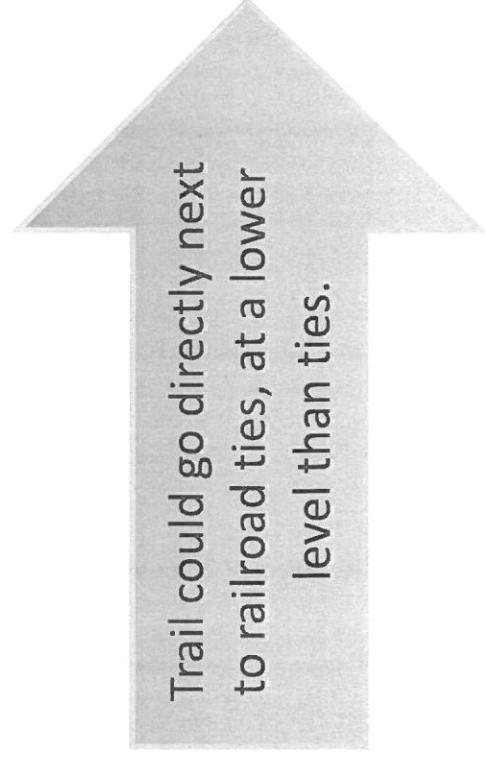

# Feasibility of having a Trail & Rail-Bikes

- Feasibility of doing a rail with trail beside it in Concord is very good! Since the rail will only be used by Rail-Bikes, the safety precautions which are taken to separate a trail with rail being used by train locomotives is not needed. Plus the majority of track has enough room to have a trail beside the track. In fact, a little over 1/3 of the track did have a second set of tracks that ran alongside the mainline.
- Here is an example of a trail with rail in NH. Look at the abandoned rail which goes from Wolfboro NH to Wakefield NH (Cotton Valley Rail Trail). This section is used for biking, walking and the Cotton Valley Rail Trail Club also runs speeders on it. In my opinion, this is much less safe than Rail-Bikes running with a walking trail alongside the tracks.





# Petition

- My understanding is the Merrimack River Greenway Trail has started a petition to support the purchase of the abandoned railroad tracks in Concord, with the intent they be torn up and used as a continuation of the MRGT.
- As the owner of Scenic RailRiders, I am not opposed to connecting the MRGT to the Northern Rail Trail. I am opposed to ripping up the tracks and taking a growing tourist attraction away from the City of Concord and depriving many local businesses of the future business they will lose if this tourist attraction is removed and replaced by a walking and bike path.
- With this in mind, I have also started a petition to keep the tracks in place and build the walking bike path either alongside the tracks or using alternative pathways. There is no reason why both cannot co-exist. I have submitted a petition with 536 signatures and I can get thousands more if needed.
- I have spoken with the board members of the Northern Rail Trail and a member of the MRGT board and they all agree both can co-exist. However, a walking bike path, unlike Scenic RailRiders will not bring the same volume of people and revenue to the area.
- Furthermore, I have spoken with the NH Hannah Duston Advisory Committee and they want to bring more people to Hannah Duston Island, which is what Scenic RailRiders is doing, as this is a destination on our Rail-Bike Tours.

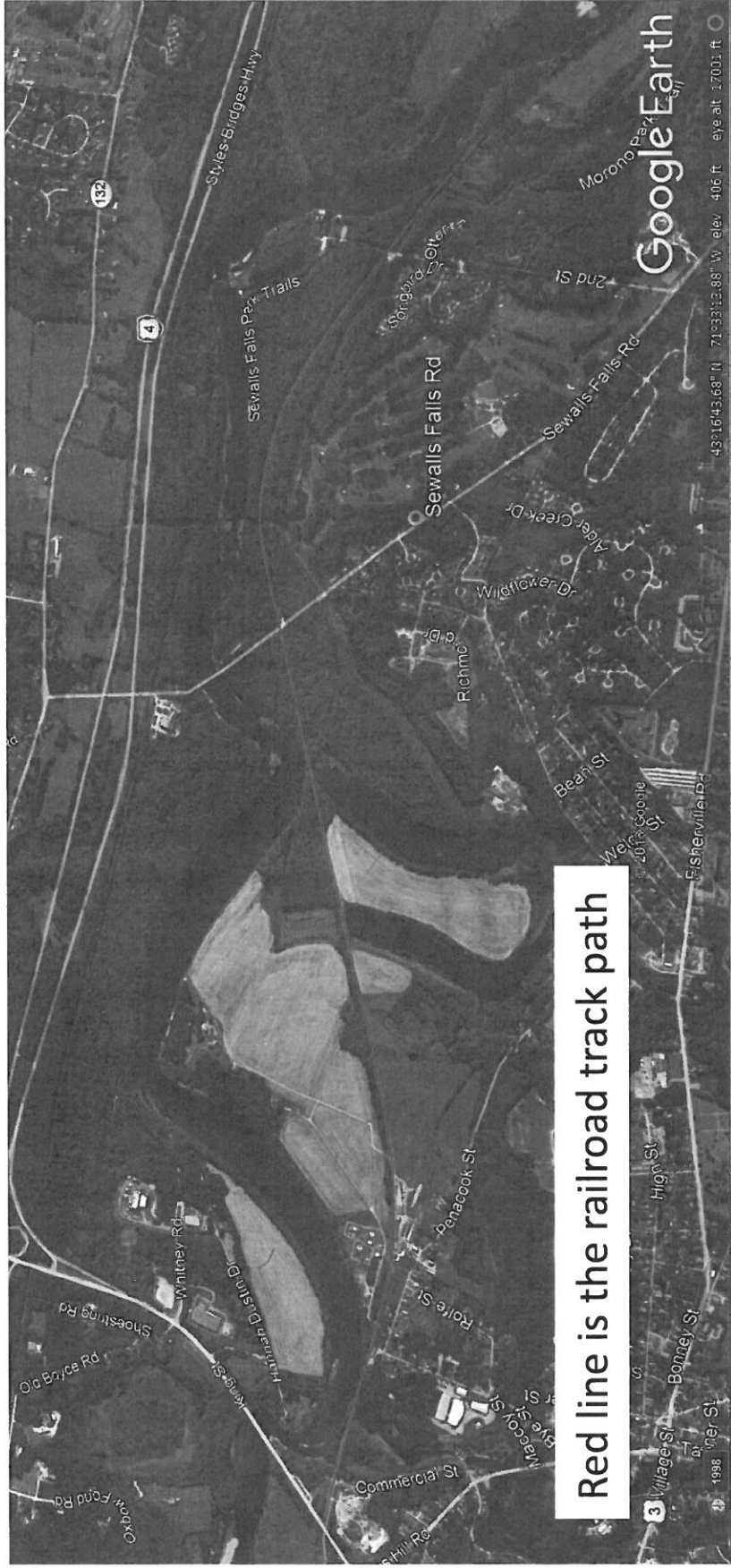
