1. Call to Order

The meeting was called to order by Chair Jaques at 4:30 p.m.

2. Minutes – Approve meeting minutes of June 12, 2025.

Member Barton moved, seconded by Vice-Chair Spain, to accept the minutes from June 12, 2025, with one spelling correction. All in favor. The motion passed unanimously.

3. New Business

a. Request for Comment for 250 Pleasant St telecommunications project Chair Jaques noted it is a cell tower by Concord Hospital and asked about the location.

Ms. Skinner stated the application indicates the installation of two new antennas at a centerline height of 79.7 feet on a 79.2-foot building with an overall building height of 159.6 feet on an existing telecommunications facility.

Chair Jaques noted it says there are no historic properties in the area and there will be no adverse impact on historic properties. Chair Jaques asked who makes the determination.

Ms. Skinner thinks SHPO makes the determination based on location within an historic district or a registered historic building. Concord only has one historic district, and the site is not in that historic district.

Member Durgy Brooks asked if they are adding to the existing cell tower configuration.

Chair Jaques answered yes.

Chair Jaques asked if any members of the Commission have any comments and with none noted the Heritage Commission has no comments for this application.

Ms. Skinner will let the applicant know.
