Reports

33. Report from the Transportation Engineer presenting options for pedestrian and bicycle accommodations for the future Loudon Road Bridge improvements.

Action: City Manager Aspell introduced City Engineer David Cedarholm who provided a detailed overview of the potential pedestrian and bicycle accommodations, as well as estimated costs of such improvements, that could be incorporated into proposed Loudon Road Bridge improvements. Mr. Cedarholm indicated that staff was looking for direction from City Council as to which option Council wished to further investigate.

Members of City Council expressed their desire to improve pedestrian and bicycle improvements when making improvements to this bridge.

Lane realignment, at the Fort Eddy Road intersection, was discussed with City Engineer Cedarholm indicating that, in all likelihood, until the State I-93 widening project takes place, lane realignment near the Fort Eddy Road intersection will not take place.

Concerns were expressed about eliminating the right turn lane in the area with members of City Council speaking against such a change noting how much additional traffic would back up on Loudon Road.

Specific to a proposed median within the bridge design options, Councilor Nyhan asked staff to provide historical statistics on accidents, specifically head on collision accidents, on the Loudon Road bridge for Council consideration when making final design recommendations.

After lengthy discussion about the potential options, City Council consensus was that options 4 and 5 were acceptable, with option 5 being the preferred choice. Concerns were expressed about the total cost of potential improvements to this bridge. City Council asked staff to come back to Council with final pedestrian and bicycle improvement recommendations after meeting with the State Department of Transportation about the options and overall cost.

New Business

33A. Discussion of COVID related grants.

Action: Mayor Bouley, recognizing the COVID pandemic has financially hurt local businesses, addressed Council and suggested City Council consider repurposing \$15,000 of the \$30,000 originally approved for July 4th fireworks and establishing a grant program for local restaurants to apply for funds to be used to invest in plexiglass and/or other appropriate safety protocols to create safer environments within their individual businesses when moving all seating inside, which must be done on or before November 15, 2020.

Council consensus was that it was a great idea to pursue this grant idea for local restaurants.

Councilor Rice Hawkins spoke in support of the proposed program, asking if Mayor Bouley felt a cap for each application should be established. Mayor Bouley spoke in support of a cap, indicating he wasn't personally sure what the cap should be, because he was unsure of what the costs of items needed would be.

Councilor Champlin noted that the Chamber of Commerce did a survey of restaurants in the area that might be interested in such a grant program. Councilor Champlin indicated that the Chamber of Commerce offered to administer such a program, if approved by City Council. He indicated that he thought \$1,500 would be an appropriate cap.

Councilor Kenison inquired as to why Council wouldn't move forward with using the total \$30,000 originally appropriated for fireworks.

Councilor Pierce suggested perhaps a matching grant program should be considered.

Councilor Fennessy thanked Mayor Bouley for bringing this concept forward while suggesting a larger pot of money should be made available, if possible.

Councilor Grady Sexton spoke in support of the proposal, as well as leaving the details of the program up to City staff.

Councilor Rice Hawkins spoke in support of assisting local businesses while inquiring as to whether Council should perhaps allocate these funds to housing assistance needs within the community instead. City Manager Aspell indicated that the City should be all set in addressing housing needs based on what has been appropriated to address those needs to date. City Manager Aspell further noted

that Council should be cautious in reallocating all of the funds originally allocated for fireworks considering the future of the pandemic is unknown. City Manager Aspell also reminded City Council of the recent application the City of Concord made for \$500,000 in CDGB funds specific to addressing housing needs.

Councilor Kenison spoke in support of starting out with \$15,000, with the understanding that Council could adjust the amount at a later date.

In closing, Council consensus was to instruct City Administration to work with the Chamber of Commerce to establish a grant program, using \$15,000 of the funds originally allocated for fireworks, to establish a program for local restaurants to make safety improvements to their businesses in preparation for moving all seating indoors on or before November 15th.

Councilor Kretovic asked City Administration to come back with a resolution appropriating \$1,092 to cover the additional unfunded costs needed to complete this project. The motion was duly seconded by Councilor Rice Hawkins and passed unanimously with a roll call vote.

Action: Councilor Hatfield thanked Mayor Bouley and Members of City Council for allowing Paul and Denis Pouliot, head speakers of the Cowasuck Band of the Pennacook Abenaki People, to do the blessing.

Councilor Werner thanked the City's Public Information Officer, Stefanie Breton and the Senior Planner, Sam Durfee, for pulling together the media briefing relative to the City's efforts on the recent greenhouse gas inventory initiative project.

Councilor Keach urged residents to contact the City Clerk's Office with any questions regarding elections.

Councilor Pierce reminded Ward Two residents of their new polling location, The Barn at Bull Meadow, and thanked the City Clerk for securing this new location.

Councilor Fennessy wished the best of luck to the City Clerk's Office, as well as Ward Officials within the City, with the upcoming November 3rd State General Election.

Councilor Champlin reminded Ward Seven residents of their new polling location, the Abbot-Downing School. Councilor Champlin also reminded Ward Nine residents that they would once again be voting at the Citywide Community Center on Canterbury Road.

Councilor Kretovic encouraged residents within the Community to get out and vote on Election Day, Tuesday, November 3rd.

Mayor Bouley thanked the City Clerk's Office for their efforts on the upcoming November 3rd Election.
