WHEREAS,	the same properties were subsequently sold for \$280,000, \$105,000 and \$42,500, respectively; and
WHEREAS,	the amount necessary to satisfy the outstanding tax liabilities, interest and costs were \$40,537.42, \$13,009.54, and \$15,015.13; and
WHEREAS,	the amount refunded for 5 Lake Street was \$213,093.88 and 59 Hobart Street was \$85,408.16; and
WHEREAS,	the amount filed at the Interpleader of the Court for 69 Manchester #07 was \$22,143.77; and
WHEREAS,	the remaining proceeds of \$38,292.10 is the allowable expense of \$1,225 for Mobile Home Park rent plus the 10% of assessed value penalty, \$37,167.10 as allowed by State statute to be retained by the City; and
WHEREAS,	these funds will be used to offset future expenses that will be incurred in the taking of subsequent tax deeded property; and
WHEREAS,	this appropriation is for a purpose for which funding was not included in the fiscal year 2024 adopted budget, therefore, Section 37 of the City Charter requires two-thirds vote of the City Council.
