Riverbend Community Mental Health, Inc. is pleased to offer support to Concord Coalition to End Homelessness' (CCEH) efforts to expand housing opportunities in our community, specifically through a Permanent Supportive Housing program at 6 South State Street in Concord. Riverbend has a long standing collaborative relationship with CCEH to provide a variety of mental health and addition services to those who may be experiencing homelessness.

Riverbend is one of New Hampshire's ten (10) Community Mental Health Centers contracted with New Hampshire's Department of Health and Human Services to provide state-funded community mental health services. Riverbend is assigned to Region four (4), a geographical region that includes Concord. Any person living in the Region 4 catchment area can potentially receive services from Riverbend in accordance to all the rules and regulations governing the community mental health service delivery system in NH.

Clients are assessed for eligibility for state supported services. Once determined eligible, Riverbend works collaboratively with the client to develop individualized service plans which may include goals and/or objectives related to maintaining housing. Services available to these eligible clients include: care coordination, functional support services, supported employment, therapy and medication evaluation and management. Riverbend also has the capacity to provide Individualized Resiliency and Recovery Oriented Services (IROS) in private residences or elsewhere in the community. IROS services are aimed at helping people to cope more effectively with symptoms of severe mental illnesses which can have a large impact on a person's ability to maintain independent living arrangements. It is important to note, all services are voluntary.

Lack of housing is a critical issue in our communities. It is especially difficult for those who need support and guidance to secure long term housing. CCEH has an extremely successful history of providing safe, affordable housing. Riverbend fully supports their expansion to include 6 South State Street. We will continue to be available to support the residents.

I write this letter on behalf of the Greater Concord Chamber of Commerce in support of the CDBG grant application from the Concord Coalition to End Homelessness (CCEH) for the purchase of 6 South State Street in Concord to convert the property into 8 one- bedroom units for people exiting homelessness.

Given the current extremely low inventory of available housing at all levels, Concord's homeless population has grown considerably over the past few years. A certain percentage of these individuals will be homeless on a temporary basis, a but a growing proportion are falling into the chronic category.

The CCEH has a proven track record of seeking innovative ways to provide permanent housing and ongoing support for the chronic homeless population. The organization is dedicated to ending chronic homelessness in Concord. They believe, as I do, that this is an achievable goal. As a member of the CCEH advisory board, I have seen first hand how they have stepped up to provide emergency, low barrier housing to some of Concord's most vulnerable people during the winter months, have provided counselling, referrals and basic services (laundry, showers, clothing, basic supplies) and more. The CCEH is a crucial organization in the Concord area human service network, and partners very effectively within that network.

With a reluctance on the part of many landlords to rent to individuals with a history of homelessness, the CCEH has embarked upon a path to find small, multi family homes to purchase and rent to clients at whatever income level the client can afford. This approach, combined with ongoing support services, is a proven strategy to accomplish zero chronic homelessness.
