AN ORDINANCE amending the CODE OF ORDINANCES; Title I, General Code; Chapter 1, Government Organization, Article 1-5, Fees, Fines, and Penalties, including Schedule I and II.

The City of Concord ordains as follows:

SECTION I: amend the CODE OF ORDINANCES; Title I, General Code; Chapter 1, Government

Organization, Article 1-5, Fees, Fines, and Penalties, by amending Schedule I,

Chapter 18, as follows:

Chapter 18—Parking

Section 18-3-8, Use of Parking Meters

- (a) On-street meter spaces and/or kiosk, per hour: [\$0.75] \$1.00
- (b) Parking garages *and parking lots*, per hour: \$0.50

Section 18-3-14(g), Permit for exclusive use, per day: [10.00] \$15.00 / parking space

SECTION II: amend CODE OF ORDINANCES; Title I, General Code; Chapter 1, Government Organization, Article 1-5, Fees, Fines, and Penalties, by amending Schedule II, Chapter 19, as follows:

Chapter 19—Penalties

Section 19-1-1, Penalties (Parking Violations): The amounts set forth in the table below will be accepted as payment of a penalty for the offense charged. Except as detailed in the table below, failure by the vehicle operator or owner to make such payment within 10 business days from the date the citation was issued shall result in the fine doubling the original fine amount owed. Further, except as detailed in the table below, failure by the vehicle operator or owner to make such payment within 20 business days shall result in the fine quadrupling the original amount owed. Business Days shall mean Monday, Tuesday, Wednesday, Thursday, Friday, but excluding Municipal Holidays. Municipal Holidays shall mean New Year's Day, Martin Luther King / Civil Rights Day, President's Day, Memorial Day, Fourth of July, Labor Day, Columbus Day, Election Day (when applicable), Veteran's Day, Thanksgiving Day, Day After Thanksgiving, and Christmas Day.
