Hampshire Highway Safety Agency that we have been awarded a grant in the

amount of up to twenty-six thousand, sixteen dollars and thirty cents

(\$26,016.30); and

WHEREAS, the Concord City Council approved Resolution #8906, adopted April 11, 2016, at

their regular meeting authorizing the City Manager to apply for the above grant;

and

WHEREAS, these funds have been designated by the New Hampshire Highway Safety Agency

to be applied towards Sustained Traffic Safety Enforcement Patrols (STEP) and

the Concord Police Department desires to conduct such patrols; and

WHEREAS, there is an in-kind match by the City in the amount of \$6,504.08 required for
