**The City of Concord resolves as follows:**

**WHEREAS,** the Concord Police Department has received notification from the United States Department of Justice, Office of Justice Assistance, Edward Byrne Memorial Justice Assistance Grant Program that we have been awarded a grant in the amount of \$24,436; and

**WHEREAS,** a request to apply for this grant was approved at the August 8, 2022 regular City Council meeting; and

**WHEREAS,** the Concord Police Department desires to procure police equipment and training in the amount of \$13,936; and

**WHEREAS,** there is no financial match required for this grant program; and

**WHEREAS,** the Concord Police Department is entering into a Memorandum of Understanding with the County of Merrimack to pass through the remaining \$10,500 to the County; and

**WHEREAS,** this appropriation is for a purpose for which funding was not included in the Fiscal Year 2023 adopted budget, therefore section 37 of the City Charter requires a two-thirds vote of the City Council.

**NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:**
