SUBJECT: September Fiscal Year to Date 2016 Financial Statements

The attached financial statements for the period ending September 30, 2015 represent 25% of the elapsed Fiscal Year 2016. The highlights of the City's financial status for this time period are represented by fund or groups of funds below. Comparisons are being made to the FY16 adopted budget or previous year FY15 same period results.

General Fund

Revenues:

- 1) Still very early in the Fiscal year, revenue and expense lines are on track. Trends that develop will be identified as early as possible. Notable items will be listed below.
- 2) A general comment for the FY16 financial statements: Based on the changes made during this year's budget process, Engineering and General Services allocated costs are now recorded as Transfers-in in the revenue section of their respective budgets and the offsetting expenses from the enterprise and special revenue funds are now recorded as Transfers-out.
- 3) General Overhead
 - a. Please note that General Overhead is a new department in the City's financial statements starting in fiscal year 2016.
 - b. Insurance Distributions and Credits: this line is already over budget by \$447,500. While the premium holiday was budgeted for \$82,500, the General Fund premium holiday amount realized was \$530,000. An additional \$69,700 was distributed to other operating funds as recorded in these reports. In total the City received \$599,700 in premium holiday. This is a very positive way to start the new fiscal year.

Expenses:

- 1) Most expense items are on track with budget. It is important to recognize when reading these financial statements that FY16 has 52 pay periods. September represents 12 of 52 payrolls elapsed or 23.1%. This is the ratio that is important to use to compare wage lines to budget. Other notable items are listed below.
- 2) Assessing
 - a. Prof & Tech Services: this line is 160% spent or \$18,300 overspent, including encumbrances, year to date.

Major Enterprise and Special Revenue Funds:

Engineering Inspections Fund

No significant issues to discuss at this time.

Parking Fund

- 1) Transfer in-Capital Project Fund revenue represents closeout funds returned to cover FY16 debt service payments.
- 2) Parking rental line is \$106,900 behind FY15. The majority of this difference is a timing difference of when quarterly bills are invoiced to customers compared to FY15
- 3) Metered Parking and Parking Penalties are behind FY15 actual and FY16 budget projections. This is a direct result of the construction activities for the Complete Streets Project.
- 4) Building Services and Repairs for September includes a \$16,400 expenditure for an electrical repair at the Capital Commons Garage due to damage from a lightning strike.

Airport Fund

No significant issues to discuss at this time.

Golf Course Fund

No significant issues to discuss at this time.

Arena Fund

- 1) Transfer in-Arena Capital Project Fund revenue represents closeout funds returned to cover FY16 debt service payments.
- 2) Please note the over-expenditure in the Industrial Equipment Repairs line. This overspending is due to a \$68,000 expense for repairs to the chiller system. This expenditure will be revised as the project proceeds and other funds are identified to accommodate portions of the work.

Solid Waste Fund

Transfer in-Solid Waste Capital Project Fund revenue represents closeout funds returned to cover FY16 debt service payments.

Water Fund

No significant issues to discuss at this time.

Sewer Fund

No significant issues to discuss at this time.

All departments do a great job of monitoring their individual divisions and departments. These statements, which as provided in this format on a monthly basis, will help articulate how the City is doing overall as the fiscal year progresses.
