RESOLUTION IN RECOGNITION OF THE SERVICES OF

Lieutenant Cori J. Casey

The City of Concord resolves as follows:

WHEREAS, Lieutenant Cori J. Casey has been a faithful and loyal employee of the City of Concord for over 22 years within its Police Department. Lieutenant Casey began his Concord Police Department career in 1997 as a Police Officer. He served in the Patrol Division until 2001 when he was selected to be assigned to the Drug Enforcement Unit; and

WHEREAS, Lieutenant Casey served with distinction in the Drug Enforcement Unit. In 2002, he was assigned to the NH Attorney General's Drug Task Force. Lieutenant Casey quickly took on a leadership role within the Drug Task Force and became a Team Leader in 2003. During his tenure with the Drug Enforcement Unit and Drug Task Force, Lieutenant Casey received numerous awards and commendations stemming from illegal drug investigations and interagency cooperation; and

WHEREAS, Lieutenant Casey was promoted to the rank of Sergeant in 2005 and served as a Supervisor in the Patrol Division. In 2008, Lieutenant Casey was assigned as the Supervisor of the Training and Services Division and in 2011 he was assigned as the Supervisor of the Youth Services Unit within the Criminal Investigations Division; and

WHEREAS, In 2013, Lieutenant Casey was promoted to the rank of Lieutenant where he served in the Patrol Division as a Watch Commander until his retirement on September 26, 2019; and

WHEREAS, Lieutenant Casey served as the Department's Lead Firearms Instructor and Training Coordinator, and also served as the Department's Lead Emergency Vehicle Driving Instructor. Lieutenant Casey was instrumental in the continued development of the Department's firearms program as well as providing instruction to Department members in Use of Force and other relevant subjects; and

WHEREAS, Lieutenant Casey received the NH Congressional Law Enforcement Award in 2006 and a Special Achievement Award from the NH Attorney General in 2003. During the course of his distinguished career, Lieutenant Casey received numerous Meritorious Service and Distinguished Unit Action Bars. Additionally he received numerous Concord Police Department Letters of Commendation and Letters of Appreciation from members of the community; and

WHEREAS, Lieutenant Casey's dedication and loyalty to the Concord Police Department and City of Concord are without question; and

WHEREAS, Lieutenant Cori J. Casey's work ethic, determination, energy and dedication have time and time again benefited the City of Concord and the Concord Police Department, whether it was through his investigations of criminal activity, training and mentoring of fellow police officers, his vast experience in illegal drug investigations, or through his leadership as a Police Sergeant and Police Lieutenant.
