

Hello Mr. Layme,

I spoke with Matt Walsh and he shared with me that it is

impossible to "purchase" on-street parking spaces located on Washington St. The spaces have a 3 hour limit 7AM to Midnight.

Private property owners periodically make such requests and the City's Legal Department has consistently determined that such arrangements are not legally viable.

The Parking Committee could explore creation of a resident permit program for Washington Street. However, any such program cannot be exclusively available to the occupants of your boarding house. In addition, the City Council would have to ultimately approve enactment of a resident permit parking program.

Have you considered exploring other potential parking options on nearby private property, such as Merrimack County's 16 space parking lot located at 5 Chapel Street.

I hope this information is helpful, let me know if you have further questions.
