The City of Concord resolves as follows:

WHEREAS, the Northern Main Line Railroad is owned by a subsidiary of Pan Am

Systems Inc. ("Pan Am"); and,

WHEREAS, on March 22, 2017, the segments of the Northern Main Line located north

of Horseshoe Pond Lane in Concord were formally discontinued by the U.S. Surface Transportation Board at the request of Pan Am Systems; and,

WHEREAS, on July 7, 2021, the City entered into a Purchase and Sale Agreement with

Pan Am Systems to acquire that portion of the Northern Main Line located

between Horseshoe Pond Lane and the Contoocook River; and,

WHEREAS, on October 18, 2021, the State of New Hampshire, in accordance with RSA

228:60-b, invoked its Right of First Refusal (ROFR) to acquire this section

of the Northern Main Line; and,

WHEREAS, upon the State's enactment of its Right of First Refusal, the City's Purchase

and Sales Agreement automatically terminated; and,

WHERAS, in accordance with RSA 228:60-b, II, the City and the State desire to enter

into a Memorandum of Agreement ("MOA") to establish a partnership concerning acquisition, operation, and management of the aforementioned

segment of the Northern Main Line corridor; and,

WHEREAS, the City desires to acquire the aforementioned rail corridor for the purposes

of extending the Merrimack River Greenway Trail (CIP #543);

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that,

- The City Manager is authorized to enter into a Memorandum of Agreement with the State
 of New Hampshire concerning acquisition, operation and management of that portion of
 the Northern Main Line located between Horseshoe Pond Lane and the Contoocook
 River.
- 2. The Memorandum of Agreement shall be generally consistent with the document attached hereto; however, the City Manager is authorized to negotiate modifications thereto as might be required to facilitate the proposed partnership with the State of New Hampshire, as well as proposed real estate transactions as contemplated within the Memorandum of Agreement.
- 3. In accordance with said Memorandum of Agreement, the City Manager is authorized to jointly negotiate a Purchase and Sale Agreement with the State of New Hampshire and Pan Am Systems, Inc. for said railroad property. Once negotiated and executed by the State of New Hampshire and Pan Am Systems, the City Manager is authorized to accept assignment of said Purchase and Sale Agreement from the State. Upon assignment, the City Manager is authorized to negotiate and execute amendments to the Purchase and Sale Agreement as might be required to facilitate and complete said transaction.
- 4. Upon acceptance of assignment of said Purchase and Sale Agreement, the City Manager is authorized to resume and complete due diligence associated with the proposed purchase.
- 5. The City Manager is authorized to use funding previously appropriated by Resolution #9380 to finance acquisition of the property and related activities.
- 6. This resolution shall take effect upon its passage.
