Understandably anxious after realizing she had left her keys inside the vehicle, she was unsure of what to do and believed her only option was to contact a 24/7 locksmith. In a moment of desperation, she reached out to the Fire Department's non-emergency line. To our relief your crew promptly arrived at the scene and was able to help Michelle gain access to her vehicle quickly, professionally, and without causing any damage.
