- WHEREAS, the City desires to abate hazardous building materials located within the existing 26,000SF +/- structure to foster and promote redevelopment of the Property; and
- WHEREAS, on August 28, 2020 the City applied for \$172,500 in grant funds from the New Hampshire Department of Environmental Services Brownfields Program to partially finance hazardous building materials abatement activities at the Property; and
- WHEREAS, the New Hampshire Department of Environmental Services (NHDES) Brownfields Program approved and awarded the City's grant application on December 31, 2020; and
- WHEREAS, on May 10, 2021 the City Council approved Resolution #9375 which authorized the City Manager to into a Purchase and Sale Agreement with the John J. Flatley Company (the Developer) concerning sale and redevelopment of the Property into a new 80,000SF+/- building which shall feature approximately 64 market rate apartments; and
