- WHEREAS, the Concord Police Department has received notification from the New Hampshire Highway Safety Agency that we have been awarded a grant in the amount of \$80,100.00; New Hampshire Highway Safety awarded \$23,100.00 for Roadway Safety and Outreach Initiatives later being amended to include \$57,000.00 for C.A.R. equipment and training for a total sum of \$80,100.00; and
- **WHEREAS,** a request to apply for \$23,100.00 was approved at the June 9, 2025 City Council meeting; and later amended to \$80,100.00 as indicated in the grant agreement amendment notice; and
- WHEREAS, these funds have been designated by the New Hampshire Highway Safety Agency to be applied towards roadway safety and outreach initiatives conducted by the police department and C.A.R. Equipment and training; and
- **WHEREAS,** there is a match by the City in the amount of \$5,775.00 for roadway safety and outreach initiatives and \$14,250.00 for C.A.R Equipment and training required for accepting these funds; and
- **WHEREAS,** this match will be accounted for through administrative costs and equipment costs incurred by the Department through the life of the grant; and
- WHEREAS, this appropriation is for a purpose for which funding was not included in the Fiscal Year 2026 adopted budget, therefore section 37 of the City Charter requires a two-thirds vote of the City Council.
