Re: Petition to Expand the Boundaries of the Penacook Boscawen Water Precinct

Dear Mayor Champlin:

This office represents the Penacook Boscawen Water Precinct (the "Precinct"). Enclosed, please find the following:

- 1. Petition to expand the boundaries of the Precinct pursuant to RSA 52:5 (the "Petition");
- 2. Description of the proposed new boundary line of the Precinct; and
- 3. Maps and drawings depicting the change in boundary.

Please be aware that the Petition only involves land in Boscawen, New Hampshire. In other words, the boundaries within Concord, New Hampshire remain entirely unchanged. It is not clear that RSA ch. 52 requires the approval of the City of Concord ("Concord") in this situation; nevertheless, in an abundance of caution, the Precinct is seeking the City's approval for the above-described boundary change. This Petition has already been provided to the Town of Boscawen ("Boscawen" and, together with Concord, the "Municipalities"), which will also receive a copy of this letter.

We understand that the Municipalities will need to notice and schedule a hearing pursuant to RSA 52:5, I. Please feel free to contact me directly to discuss or coordinate any procedures or additional information you may want in advance of such a hearing.

After such hearing, assuming the expansion is approved by the Municipalities, the Precinct will schedule a meeting to ratify the decision pursuant to RSA 52:5, III and notify the Secretary of State pursuant to RSA 52:24, II(a).

Exhibit A

Beginning at point on the Concord and Boscawen Town Line, said point being the center line of the State of New Hampshire (former Boston and Maine Railroad) right-of-way, thence:

- 1. Southwesterly along the Contoocook River, a distance of 2,200 feet to a point on the eastern boundary of Boscawen tax map 183c lot 62 and the Concord and Boscawen Town Line, thence;
- 2. Westerly along the Concord and Boscawen Town line to a point Boscawen tax map 183c lot 52 and the Contoocook River, thence;
- 3. Southwesterly along the Contoocook River, a distance of 4,500 feet to Hardy Brook, thence:
- 4. Northeasterly by the Brook to a point on the southern boundary of Boscawen tax map 83 lot 62, said point being approximately six hundred (600) feet northerly from the Concord and Boscawen Town line, thence turning;
- 5. Northeasterly an approximate distance of 1,850 feet on the boundary of Boscawen tax map 83 lot 62 to the southeast corner boundary of the Boscawen tax map 83 lot 62, thence turning;
- 6. Northerly approximately distance of 1,800 feet, crossing Queen Street, to a northeast corner on Boscawen tax map 83 lot 30A, thence turning;
- 7. Northeasterly an approximate distance of 700 feet to the northwest corner of Boscawen tax map 83 lot 29B, thence turning;
- 8. Northeasterly an approximate distance of 2,000 feet to the southwest corner of Boscawen tax map 83 lot 6, thence turning;
 - 9. Northwesterly an approximate distance of 4,700 feet to the southwest corner Boscawen tax map 81B lot 40, thence turning;
 - 10. Northerly an approximate distance of 2,300 feet to the southeast corner of Boscawen tax map 81B lot 25, thence turning;
 - 11. Westerly an approximate distance of 2,000 feet on the southern lot boundary line of Boscawen tax map 81B lots 25, 24, 23, 21, 12, and 11, thence continuing to southern corner of Boscawen tax map 81B lot 9, thence turning;

BOUNDARY CHANGE

- 9 Northwesterly approximately 1,300 feet to the southwest comer of Boscawen tax map 81B Lot 54, thence continuing,
- 9A Northwesterly approximately 1,370' along the westerly lot between Boscawen tax map 81B Lot 54 and map 83 Lot 7, thence turning
- 9B Northeasterly approximately 920' to the westerly corner of Boscawen tax map 81B Lot 54 and Tax Map 81B Lot 46, thence turning,
- 9C Northwesterly approximately 1,700 feet to the southwest corner of Boscawen tax map 81B Lot 40.
