Dear Chief Chisholm,

Two and a half years ago, my wife Nora and I moved from Danbury, Connecticut to [REDACTED] Street, Concord. Retired, in our early seventies and having survived some severe traumatic events in Connecticut, we felt a need for a fresh start and to be closer to our family. Our daughter and her family live in the Boston area and my brother Mark and his family have lived in Concord for many years. We'd visited Concord often over the years, finding it to be affordable, accessible and friendly with much to offer. We moved into our new home Thanksgiving time, 2020. In March, 2021 Nora was diagnosed with terminal bile duct cancer, dying in January, 2022.

I am sharing this with you to express gratitude for the services we received from the personnel of the Concord Fire Department. We received end of life hospice services through Granite VNA. As Nora's strength waned, I called 911 for assistance from falls she had taken. Never did we have to wait more than a few minutes. Always the people from the Concord Fire Department were professional, thorough and most importantly, compassionate. Please extend this thank you to your staff for such loving care on behalf of Nora and our family. Please accept this donation to assist in the continuance of that care.
