**The City of Concord resolves as follows:**

**WHEREAS,** the City of Concord transferred Assigned Fund Balance funds to the Equipment and Education/Training reserve; and

**WHEREAS,** the City is in need of additional funds for the City Hall Door Project and various furniture and equipment purchases; and

**WHEREAS,** the City desires to continue to support various education and training opportunities; and

**WHEREAS,** use of these funds is drawn entirely from reserve funds and does not directly impact the amount to be raised in taxes; and

**WHEREAS,** this appropriation is for a purpose for which funds were not included in the Fiscal Year 2022 adopted budget; therefore, Section 37 of the City Charter requires a two-thirds vote of the City Council.

**NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:**

be and is hereby appropriated as follows:

General Fund

Furniture and Equipment.....	\$120,000
Education and Training .....	<u>\$10,000</u>
Total	\$130,000

2. Funding to meet said appropriation shall be provided from the following sources:

General Fund

Transfer-in from Equipment reserve .....	\$120,000
Transfer-in from Education and Training reserve .....	<u>\$10,000</u>
Total	\$130,000
