AN ORDINANCE amending the CODE OF ORDINANCES, Title I, General Code; Chapter 1, Government Organization, Article 1-5, Fees, Fines, and Penalties, Schedule I

The City of Concord ordains as follows:

SECTION I: Amend the CODE OF ORDINANCES, Title I, General Code; Chapter 1, Government Organization; Article 1-5, Fees, Fines, and Penalties, Schedule I, by amending Chapter 9, Water, Section 9-1-6, Water Use Rates, as follows:

Chapter 9—Water

Section 9-1-6, Water Use Rates

Monthly Water Rates

- Tier 1 - For the first 300 cu. ft. or part thereof~~[3.43]~~ **3.92**
- Tier 2 - For the next 3,000 cu. ft. or part thereof, per 100 cu. ft.~~[3.43]~~ **3.92**
- Tier 3 - For the next 30,000 cu. ft. or part thereof, per 100 cu. ft.~~[3.43]~~**3.92**
- Tier 4 - For the next 300,000 cu. ft. or part thereof, per 100 cu. ft.~~[3.43]~~ **3.92**
- Tier 5 - For all over 333,000 cu. ft., per 100 cu. ft. ~~[3.43]~~ **3.92**

SECTION II: Amend the CODE OF ORDINANCES, Title I, General Code; Chapter 1, Government Organization; Article 1-5, Fees, Fines, and Penalties, Schedule I, by amending Chapter 9, Water, Section 9-1-8, Water Fixed Charge, as follows:

Section 9-1-8, Water Fixed Charge

Fixed Monthly Water Charges by Meter Size:

5/8 inch [6.38]	7.71
1 inch [15.94]	19.28
1.5 inch [31.85]	38.54
2 inch [50.97]	61.67
3 inch [95.57]	115.63
4 inch [159.28]	192.72
6 inch [318.75]	385.66
8 inch [509.68]	616.66

SECTION III: Amend the CODE OF ORDINANCES, Title I, General Code; Chapter 1, Government Organization; Article 1-5, Fees, Fines, and Penalties, Schedule I, by amending Chapter 9, Water, Section 9-3-8 Sewer Use Rates, as follows:

Section 9-3-8, Sewer Use Rates

Monthly Sewer Rates:

Charge per 100 cu. ft. consumption [~~5.64~~] **7.11**

SECTION IV: Amend the CODE OF ORDINANCES, Title I, General Code; Chapter 1, Government Organization; Article 1-5, Fees, Fines, and Penalties, Schedule I, by amending Chapter 9, Water, Section 9-3-8(a), Sewer Fixed Charge, as follows:
