*The City of Concord resolves as follows:*

**WHEREAS,** the Concord Police Department has received notification from the New Hampshire Highway Safety Agency that we have been awarded a grant in the amount of up to twenty-four thousand fifty-three dollars and seventy-eight cents (\$24,053.78); and

**WHEREAS,** the Concord City Council approved Resolution #8986, adopted April 10, 2017, at their regular meeting authorizing the City Manager to apply for the above grant; and

**WHEREAS,** these funds have been designated by the New Hampshire Highway Safety Agency to be applied towards DWI/Impaired Driver Patrols and the Concord Police Department desires to conduct such patrols; and

**WHEREAS,** there is an in-kind match by the City in the amount of \$6,013.45 required for accepting these funds; and

**WHEREAS,** this match will be accounted for through administrative costs and equipment costs incurred by the Department through the life of the grant; and

**WHEREAS,** this appropriation is for a purpose not included in the Fiscal Year 2018 adopted budget, therefore section 37 of the City Charter requires a two-thirds vote of the City Council.

***NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:***
