The City of Concord resolves as follows:

- **WHEREAS**, the property owner of 13 Lawrence Street (MBL 634z/32) approached the City regarding future development; and
- **WHEREAS**, the existing parcel is boarded on the west by Lawrence Street Extension (a private street), has access to municipal sewer and water is serviced by a 2-inch line that will be insufficient for future development; and
- **WHEREAS,** the Fiscal Year 2024 Capital Improvement Program and Budget approved the replacement of the existing water main and repaving Lawrence Street (CIP #85); and
- **WHEREAS,** City staff notified the property owner this work was scheduled for the spring 2024 and once the street is paved there would be a 5 year no dig moratorium; and
- WHEREAS, in order to avoid future damage to Lawrence Street, the property owner asked the City to install an 8-inch water stub extending to Lawrence Street Extension, beyond the public right of way, and they would pay the City for the cost of the work; and
- WHEREAS, the cost to complete this work was \$4,000 and the City has been paid in full; and
- **WHEREAS,** this appropriation is for a purpose for which funding was not included in the Fiscal Year 2024 adopted budget, therefore Section 37 of the City Charter requires a two-thirds vote of the City Council.
