Call to Order

The meeting was called to order at 6:05 PM.

Accept minutes of June 15, 2015 Annual Meeting

A move to accept the minutes of the last meeting was made by C. Casco and seconded by M. De Vorsey.

<u>Library Director's Report and Monthly Update</u>

Summer Concert report: Poor weather for 3 of the 4 concerts impacted the attendance and meant that the event was held in the library auditorium but attendance still averaged 80 people and the one outdoor concert had over 150 patrons.

There was a record attendance of 250 people for the Princess FROZEN event in late summer.

National Library Card month: This is a competition with all NH libraries to reach and sign-up new card holders. Started by Todd Fabian, eight libraries signed up to participate so far and the number is expected to grow before Oct. 1st when signup closes.

40 people attended our first adult coloring event.

The first bright board programming system is up in the Children's area. The second board will be displayed on the main floor soon. Boards will be hooked up

to cable in the near future in case relevant local coverage may be helpful to stream on occasion.

IT: Comcast is working on a solution for slowdowns and loss of wifi in parts of the main building by rerouting the traffic through the Penacook branch node temporarily. There are signs in the library telling patrons of the problem.

IT continued: The Concord Monitor reported on a local issue in West Lebanon library with use of TOR by patrons. This is a freedom of speech issue. The West Lebanon Trustees will meet soon to make a decision on whether to continue using TOR that may affect other libraries nationally.

Food for Fines drive: For patrons who owe less than \$50, any approved food item donated will result in \$5 off library fines. This drive runs Sept. 13-26.
