Ms. Kretovic,

I hope you are well - I'm not sure if you remember, but we met briefly on Election Day back in November.

As I believe I mentioned at that time, my wife Erika, and I, moved into Ward 3 (from Ward 2) shortly before the November Election.

We live at the intersection of N. State and Clarke and have noticed that there have been a lot of problems with traffic in our area that we believe could be alleviated by having a traffic light somewhere in the N. State/Clarke/Lake Street area.

Since moving into our home in October, we have frequently observed speeding vehicles; at least once a week, we hear the school bus driver have to use the horn as they are dropping

children off at the Lake/Clarke intersection because a driver in the opposite direction does not stop for the bus. As I am sure you are aware, the Concord Area Transit bus stops are in close proximity to the intersection - I imagine the traffic can be an issue to people who use the bus as well. And of course, while we don't know what we don't know, I can't help but think that last week's rollover accident basically right outside our door could have been prevented if a traffic light forced the driver that caused the accident to slow down and be so distracted as they drove.

I imagine that even though N. State is technically a state route, this is technically something the City is in charge of?
