## The City of Concord resolves as follows:

- WHEREAS, the Concord Coalition to End Homelessness (the Coalition) is a not-for-profit organization whose mission is to "eliminate chronic homelessness; support and quickly re-house people who have recently become homeless; and build a system that effectively responds to the diverse needs of people experiencing homelessness"; and
- WHEREAS. the Coalition has entered into a Purchase Option Agreement to acquire real estate located a #6 South State Street (the Property) for the purpose of renovating the existing building into an 8-unit multifamily apartment building; and
- WHEREAS, said residential dwelling units shall be reserved for low- and moderate-income persons existing homelessness; and
- WHEREAS. the City of Concord desires to secure Community Development Block Grant funds to support acquisition of the Property and development of said residential dwelling units; and
- WHEREAS. Community Development funds are available through the New Hampshire Community Development Finance Authority, Community Development Block Grant Program Division, to assist such projects; and
- this appropriation is for a purpose for which funding was not included in the WHEREAS, Fiscal Year 2023 adopted budget, therefore, section 37 of the City Charter requires a two-third vote of the City Council.
