

CITY OF CONCORD

In the year of our Lord two thousand and seventeen

AN ORDINANCE amending the CODE OF ORDINANCES; Title II, Traffic Code; Chapter 18, Parking; Article 18.1, Stopping, Standing and Parking.

The City of Concord ordains as follows:

SECTION I: Amend the CODE OF ORDINANCES, Title II, Traffic Code; Chapter 18, Parking; Article 18.1, Stopping, Standing and Parking; Schedule VII, Bus and Taxicab Stands; by deleting the following:

Street	From	To
[N. Main St., east side	Pleasant St. Ext.	80' northerly
Pleasant St., north side	70' west of N. Main St.	45' westerly]

SECTION II: Amend the CODE OF ORDINANCES, Title II, Traffic Code; Chapter 18, Parking; Article 18.1, Stopping, Standing and Parking; Section 18-1-9; by adding the following subsection:

(c) When signs are erected giving notice thereof, no person shall park a vehicle between the hours designated thereon, on any weekday, in a bus or taxicab stand described in Schedule VII(a).

SECTION III: Amend the CODE OF ORDINANCES, Title II, Traffic Code; Chapter 18, Parking; Article 18.1, Stopping, Standing and Parking; Schedule VII, Bus and Taxicab Stands; by adding the following schedule and locations:

SCHEDULE VIIa, Bus and Taxicab Stands During Certain Hours (See Section 18-1-9(c))

Street	From	To	Times
<i>Pleasant St., north side</i>	<i>140' west of N. State St.</i>	<i>45' westerly</i>	<i>6:00 a.m. to 7:00 p.m. Weekdays</i>
<i>Pleasant St., south side</i>	<i>190' west of S. State St.</i>	<i>50' easterly</i>	<i>6:00 a.m. to 7:00 p.m. Weekdays</i>

SECTION IV: Amend the CODE OF ORDINANCES, Title II, Traffic Code; Chapter 18, Parking; Article 18.1, Stopping, Standing and Parking; Schedule I, Parking Prohibited at All Times; by modifying two location as follows:

Street	Side Restricted	From	To
[Pleasant St.]	North	North Main St.	74' westerly
<i>Pleasant St.</i>	<i>North</i>	<i>North Main St.</i>	<i>70' westerly</i>
[Pleasant St.]	South	South Main St.	95' westerly
<i>Pleasant St.</i>	<i>South</i>	<i>South Main St.</i>	<i>105' westerly</i>

SECTION V: Amend the CODE OF ORDINANCES, Title II, Traffic Code; Chapter 18, Parking; Article 18.1, Stopping, Standing and Parking; Schedule X, Location of Parking Meters; by modifying two locations as follows:

Street	Side Restricted	From	To
[Pleasant St.]	North	74' of North Main St.	Fremont St.]
<i>[Pleasant St.]</i>	<i>North</i>	<i>70' west of North Main St</i>	<i>Federal St.</i>
[Pleasant St.]	South	95' west of South Main St.	South Spring St.]
<i>Pleasant St.</i>	<i>South</i>	<i>105' west of South Main St.</i>	<i>South Spring St.</i>

SECTION VI: This ordinance shall take effect upon its passage.
