Good morning:

I just finished reading the article about the conditions on Bog Road and noted that there is a public hearing tonight. I am unable to attend, but I would like to add my voice to those concerned about the terrible conditions of pavement on Bog Road.

While I live in East Concord, my husband and I are both cyclists, and years ago Bog Road used to be one of our favorite roads. Now, when we want to cross the river and do rides on the west side of town, we avoid Bog Road like the plague.

While Bog Road can be jarring to passengers in a car, and can break struts and such on the vehicles, Bog Road can be downright dangerous for cyclists. The cracks are so wide that a tire could easily slip into them, and could cause a rider to go over the handlebars. Additionally, because of the numerous cracks, it's hard to find a safe lane in which to ride, without irritating passing motorists or putting oneself in harm's way.

The City has been very responsive in the past when residents raised concerns about road conditions. Several roads in East Concord were paved a few years ago, and Hoit Road – another road full of potholes and cracks - was finally paved last summer.

I hope the City will hear residents' concerns about Bog Road and be similarly responsive.

I understand that the city council will be meeting this evening to discuss road improvements for the upcoming year. As a resident of Bog Road, I would like to ask that council members give careful thought to the need of improvements of the road. Bog Road sees a high amount of traffic on a daily basis. I work in Dunbarton but no longer use my own road to make that trip to work and back because of the extremely poor conditions. I used to travel on the wrong side of the road, depending on which direction I was going, to avoid the huge holes and shifts in pavement. Then I tried to straddle the centerline but have decided that is not even a good idea because of the difference in heights from one side of the road to the other and the fear of my car bottoming out on that ridge. I don't know how delivery trucks, school buses, etc. are expected to continue to use this road in its current condition. It is deplorable! I realize it is not a matter of simply paving over what is there so it will be a major construction project, but do feel it is something that needs serious consideration in the very near future. I would appreciate my concerns being passed along to the council members as they meet this evening.
