The City of Concord resolves as follows:

- WHEREAS,** in response to the COVID-19 pandemic, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed by Congress and signed into law by President Trump on March 27th, 2020; and
- WHEREAS,** Title XII of Division B of the CARES Act provides approximately \$10 billion to support U.S. airports experiencing severe economic disruption caused by the COVID-19 public health emergency; and
- WHEREAS,** the City of Concord was deemed eligible to receive \$30,000 in CARES Act funding for the general operations and maintenance of the Concord Municipal Airport for expenses incurred since January 20, 2020; and
- WHEREAS,** these funds would be administered by the New Hampshire Department of Transportation Bureau of Aeronautics on behalf of the CARES Act; and
- WHEREAS,** as part of its May 11, 2020 agenda, the City Council was notified of the City Manager's application to receive these funds; and
- WHEREAS,** the City has since been notified of the award; and
- WHEREAS,** the Airport will use these dollars for eligible repairs & maintenance, building supplies and professional service expenses; and
- WHEREAS,** there is no financial match required for this grant; and
- WHEREAS,** the City has until May 25, 2024 to seek reimbursement for allowable costs; and
- WHEREAS,** this appropriation is for a purpose not included in the Fiscal Year 2021 adopted budget, therefore section 37 of the City Charter requires a two-thirds vote of the City Council.
