the Concord Police Department has received notification from the New WHEREAS, Hampshire Department of Safety – Law Enforcement Opioid Abuse Reduction Initiative that the City of Concord has been approved to receive funding in the amount of \$45,000 designated to cover overtime costs associated with implementing enhanced strategies focused on addressing the illegal drug/opioid crisis facing the City; and WHEREAS, the Concord City Council approved Resolution #9482, adopted August 8, 2022, at their regular meeting authorizing the City Manager to apply for the above grant; and the Concord Police Department desires to utilize this funding to cover overtime WHEREAS, costs associated with augmenting the Department's efforts in combatting the illegal drug/opioid crisis facing the City and surrounding communities; and
