**The City of Concord resolves as follows:**

**WHEREAS,** the Concord Police Department has received notification from the United States Department of Justice, Office of Justice Assistance, Edward Byrne Memorial Justice Assistance Grant Program, that we have been awarded a grant in the amount of twenty-one thousand, six hundred and eighty-five dollars (\$21,685); and

**WHEREAS,** the Concord Police Department desires to procure police equipment and training in the amount of \$10,843; and

**WHEREAS,** there is no match required for accepting these funds; and

**WHEREAS,** the Concord Police Department is entering into a Memorandum of Understanding with the County of Merrimack to pass through the remaining \$10,842 to the County; and

**WHEREAS,** this appropriation is for a purpose not included in the Fiscal Year 2021 adopted budget, therefore section 37 of the City Charter requires a two-thirds vote of the City Council.

**NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Concord that:**
